

‘Switch to our new BSB’ Terms and Conditions

Instructions on how to enter and prizes form part of these terms and conditions.

Section 1: General Information

- Promoter:** Queensland Country Bank Limited (ABN 77 087 651 027 AFSL/Australian Credit Licence 244 533), 333 Ross River Road, Aitkenvale QLD 4814. The Promoter can be contacted on 1800 075 078.
