

## 'Switch to our new BSB' Terms and Conditions

Instructions on how to enter and prizes form part of these terms and conditions.

## **Section 1: General Information**

- 1. **Promoter:** Queensland Country Bank Limited (ABN 77 087 651 027 AFSL/Australian Credit Licence 244 533), 333 Ross River Road, Aitkenvale QLD 4814. The Promoter can be contacted on 1800 075 078.
- 2. **Promotion Period:** The Promotion will run between 12:00am on Monday, 8 August 2022 until 11:59pm on Tuesday, 31 January 2023 (AEST).
- 3. Eligibility: To be eligible to enter the draw, entrants must satisfy the following criteria:
