Who is eligible for a Business Green Car Loan?

* Age of the car will be determined by the build date. New or demonstrator green vehicles only. A 'green' vehicle is defined as one with emissions intensity that does not exceed 120 grams of CO2 emissions per km (g/km). This category includes many electric and plug-in hybrid vehicles.
