Terms and Conditions

Instructions on how to enter and prizes form part of these terms and conditions.

Section 1: General Information

- 2. <u>Promotion Period:</u> The Promotion will run from 9.00am on Tuesday, 1 July 2025 and will close at 5.00pm on Sunday, 31 August 2025.
- 3. Eligibility for Individual Draw:

- (b) All entrants must be a Queensland Country Bank Member;
- (c) All entrants must be 16 years and over;
- (d) All entrants must be a resident of Australia to enter during the promotion period;
- (e) Entrants cannot be a director, employee or an immediate family member of a director or employee, of the Promoter or its related entities;
 - (i) *Immediate family member* includes your spouse or partner, your (or your spouse's) children, parents or other relatives, provided these live permanently with you;

Individual Draw
